## Who can apply for RSIF Scholarships?

CRA members, their employees and their college -age children are all eligible.

## Why should I apply?

Every student can use a helping hand. Perhaps you are considering continuing your education, or would like to attend a trade or certificate program that will enhance your job skills. One of the missions of RSIF is to promote education in the rental industry and that applies to adult students of all ages, and at many levels.

## What are the requirements for eligibility?

CRA members, their employees and their college -age children are all eligible. Full or part time students in trade schools, community colleges or universities are eligible to apply. Applicants must be CRA members, their employees or their college-age children. Awarded scholarships are paid upon successful completion of the term with at least a C average, and if a full-time student, at least 12 units must be completed.

## When do I apply?

RSIF scholarships are awarded twice each year, for the fall and spring terms. Deadlines for submitting your application are June 30 for the fall term and December 31 for the spring term.
